He also successfully ran the national award-winning **Greater Toledo Urban League** for 10 years; The **Madison Urban League** in WI; and The **Greenville Urban League** in SC. **Mickler** began his professional career as a cost-accountant with **CRS-Sirrinc**, a design & construction engineering firm in Upstate SC. He's earned **three (3) Associate of Science degrees** from **Greenville Tech** in **Accounting, Marketing, and Management**; a **Bachelor of Science degree** from **Limestone College** in **Business Mgt.**; and, he has earned several hours toward his **Master's degree** in **Human Resource Management** at **Clemson University**.

A community activist at heart, **Mickler has served on several area boards:** The **Medical College of Ohio Foundation**, **Owens Community College Foundation, Inc.**, the **Corporation for Effective Government**, and the **Northwest Black Chamber of Commerce**. Mickler was a member and Vice-Chair of the **Ohio Council of Urban Leagues**. Also, he served on a national-level for prospective CEO's.

Peggy taught me to ride a horse two weeks ago for the first time and it went poop while I was riding! I just sat on the horse because I didn't want to clean it up. We go swimming at the **Holiday Inn** and at the beach where Peggy lives. I went to Pennsylvania with Peggy, we went swimming, to the zoo, shopping, to see a show with ballerinas and out to eat. I had never been to Pennsylvania before; it was fun staying in a hotel. I like to dance and Peggy dances with me.

Peggy helps me do math with M&Ms. She tells me to count them and put them in a group in a circle. Then I have to times them and count them to get my answer. If I get the answer right I get to eat the M&Ms. Peggy also helps me with my science projects. When Peggy helps me it is much easier to do. We go skating at the skating ring. My first time on skates, I fell on my butt and was crying. Peggy helped me up and told me that I needed to keep trying. Now I skate good without falling all the time.

Traditional Mentoring

Provides children 5-15 years old with a mentoring relationship with a qualified adult-volunteer in which — the "Match" spends a few hours each week enjoying activities together — and building a strong and lasting relationship.

Site-Based Mentoring

Serves children ages 5-15 years old with a mentoring relationship in a supervised group setting, at a predetermined site for one-hour, one-day a week.

The M-3 Project

Provides services to children 5-15 years old in an effort to help them avoid being drawn into alcohol, nicotine or other drug use.

WIA Project: A Mentoring Tescera

Provides mentoring and job-skills training/coaching to help students 16-18 years old improve academic achievement, develop job-skills, enjoy a mentor/mentee matched relationship and have a positive volunteer/work experience.

Mentoring Children of Prisoners ~ Amachi

Serves children 4-15 years old — who have one or both parents — currently incarcerated in a **State** or **Federal** correctional facility.

Office of Juvenile Justice & Delinquency Prevention (OJJDP)

Provides mentoring services to targeted youth (ages 9 to 18) — with the intent of reducing juvenile delinquency, drug abuse, truancy, chronic absenteeism — and other problematic and high-risk behaviors.
